Corporal Trevor Reimer—RCMP St Walburg Detachment

At Council's request, Corporal Trevor Reimer attended the meeting to provide an update on local policing. Corporal Reimer states that detachment serving the Village is at 50% strength and that this is an improvement. The numbers are expected to stay stable or even improve over the next year. Corporal Reimer detailed problems with apprehending criminals—the area covered by the local members is quite large, a stringent burden of proof and conviction before being able to lay charges, and an unwillingness by the public to get involved. Crimes against people take precedence over property crimes. His suggestions were to observe and document unusual activity, and to provide information to members upon request and be willing to make a statement and appear as a witness.
